

1 Amend 2 Cal. Code Regs. Section 18735 to read:

2 **§ 18735. Change of Position or Disclosure Category Within Same Agency.**

3 (a) Transferring to a Designated Position. Except as specified otherwise in this regulation,  
4 a designated employee who transfers from one designated position to another designated position  
5 within the same agency has not assumed or left office within the meaning of Section 87302 or the  
6 agency's conflict-of-interest code. The next ~~Statement of Economic Interests~~ statement of  
7 economic interests the employee files shall disclose both of the following:

8 (1) Interests made reportable by the employee's original disclosure category that were  
9 held or received at any time during the period from the opening date of the statement to the  
10 transfer date.

11 (2) Interests made reportable by the employee's new disclosure category that were held or  
12 received at any time during the period from the date of the transfer through the closing date of the  
13 statement.

14 (b) Transferring to an Executive Position. A designated employee who transfers to the  
15 position of board member, commissioner, executive director, or other chief executive officer  
16 within the same agency shall file a leaving office statement of economic interests and an  
17 assuming office statement as required by Sections 87202(a), 87204, or 87302(b) as applicable.

18 ~~(b) A designated employee who transfers to the position of board member, commissioner,~~  
19 ~~head of an agency, executive director, or other chief executive officer within the same agency~~  
20 ~~and designated in the agency's conflict of interest code shall:~~

21 ~~(1) Within 10 days of the transfer, file with the person or agency specified in Section~~  
22 ~~87500, for the position to which the employee is transferring, an amendment to his or her most~~

1 recent Statement of Economic Interests providing the following information:

2 (A) ~~The employee's new position or office.~~

3 (B) ~~The date of the transfer.~~

4 (C) ~~Investments, business positions, and interests in real property held on the date of the~~  
5 ~~transfer, and income received during the 12 months before the date of the transfer, which must be~~  
6 ~~disclosed under the employee's new disclosure category and were not reported on the employee's~~  
7 ~~last Statement of Economic Interests.~~

8 (2) ~~Disclose interests on his or her next Statement of Economic Interests held or received~~  
9 ~~since the employee's last statement as required by subdivisions (a)(1) and (a)(2).~~

10 (c) New Term of Office. A designated employee who, at the expiration of ~~his or her~~ the  
11 employee's term, begins a term in the same position within the same agency within 30 days has  
12 not assumed or left office within the meaning of Section 87302 or the agency's conflict-of-  
13 interest code. The employee shall continue filing annual statements at the time specified in ~~his or~~  
14 ~~her~~ the agency's conflict-of-interest code.

15 (d) New Disclosure Category. A designated employee has not assumed or left office  
16 within the meaning of Section 87302 or the agency's conflict-of-interest code if the employee's  
17 agency changes the disclosure category for the employee's position between the filing dates for  
18 the designated position. The next ~~Statement of Economic Interests~~ statement of economic  
19 interests the employee files shall disclose both of the following:

20 (1) Interests made reportable by the employee's original disclosure category that were  
21 held or received at any time during the period from the opening date of the statement to the date  
22 the agency's code was amended.

1 (2) Interests made reportable by the employee's new disclosure category that were held or  
2 received at any time during the period from the date the agency's code was amended through the  
3 closing date of the statement.

4 (e) Transfer to Member of the Legislature. A designated employee of the Legislature who  
5 ~~holds a position with the same disclosure requirements as a member of the Legislature and who,~~  
6 ~~within 30 days of leaving the~~ leaves that designated position, assumes office in the month of  
7 ~~December or January~~ to assume office as a member of the Legislature shall file a leaving office  
8 statement of economic interests for the former designated position pursuant to Section 87302(b),  
9 and an assuming office statement for the new position of being a member of the Legislature  
10 pursuant to Section 87202(b), may file an annual Statement of Economic Interests disclosing  
11 ~~investments, business positions, interests in real property, and income held or received during the~~  
12 ~~period since the last statement he or she filed as a designated employee. If filed, this statement~~  
13 ~~serves as both the leaving office statement required under Section 87302(b) and the assuming~~  
14 ~~office statement required under Section 87202(b).~~

15 (f) Transfer to Designated Employee of the Legislature. A member of the Legislature who  
16 leaves office and subsequently becomes a designated employee of the Legislature shall file a  
17 leaving office statement of economic interests as required by Section 87204 and an assuming  
18 office statement under Section 87302(b).
