Dear Chloe Hackert,

I hope this message finds you well. On behalf of the City of San Dimas, I am writing to request that agencies be allowed to continue utilizing their own established filing systems for Statements of Economic Interests (Form 700). We believe this flexibility will enable agencies to maintain the operational efficiency and integrity of their current processes.

While we understand the importance of standardization, we would like to highlight the potential impacts that could arise if a uniform filing system were to be mandated:

- 1. **Disruption of Existing Processes:** Many agencies, including ours, have developed systems tailored to our specific workflows and needs. Requiring a switch to a new system could disrupt operations and cause delays, particularly during the transition phase.
- 2. **Resource Demands:** Implementing a new filing system may require significant resources, including staff training, technical adjustments, and possibly additional technology investments, which could be a financial burden.
- 3. **Loss of Operational Efficiency:** A one-size-fits-all approach may not cater to the unique needs of each agency (such as more seasoned elected who file hard copies), potentially leading to inefficiencies or increased workload in managing these filings.
- 4. **Data Migration Risks:** Migrating to a new system always poses a risk of data loss, inconsistencies, or system errors, which could create compliance concerns or delays in processing.

Given these considerations, we respectfully request that agencies be granted the option to continue using their own filing systems while ensuring compliance with all legal and regulatory requirements. We believe this approach will allow for the smooth and effective management of Statements of Economic Interests without introducing unnecessary disruptions.

We are, of course, willing to discuss any additional steps needed to ensure consistency and transparency across agencies while maintaining flexibility in the filing process.
