

**Fair Political Practices Commission**  
**Filing Schedule for Political Party Committees**  
**January through December 2022**  
**Including Activity for State Special Primary and Special General Elections**  
**April 5, June 7, and November 8, 2022**

**Note:** Political party committees must file pre-election statements in connection with any state election, including a state special election, if the committee receives contributions of \$1,000 or more, or makes contributions or independent expenditures of \$500 or more in connection with a state election. This may be true even if the committee does not make a payment in connection with the particular election by virtue of receiving contributions during the applicable reporting period. This includes state elections held in both even and odd numbered years.

<b>Within 10 Days</b> <i>Independent Expenditure Verification</i>	<b>Ongoing</b>	<a href="#">462</a>	<ul style="list-style-type: none"> <li>• Committees making independent expenditures must file this form with the FPPC by e-mail only. No paper copy is required.</li> <li>• Committees file only one Form 462 per election for each candidate or measure supported or opposed by an independent expenditure. Until the California Access Replacement System (CARS) is live, committees making independent expenditures must file this form with the FPPC by e-mail only, no paper copy is required. Once the CARS system is live, this report will be eliminated as the information will be captured on other statements and reports.</li> </ul>
<b>Within 10 Business Days</b> <i>\$5,000 Report State Ballot Measure Payments</i>	<b>Ongoing</b>	<a href="#">496</a> <a href="#">497</a>	<ul style="list-style-type: none"> <li>• <b>496:</b> Report each independent expenditure totaling \$5,000 or more to support or oppose the qualification or passage of a single state ballot measure.</li> <li>• <b>497:</b> Report each contribution totaling \$5,000 or more to support or oppose the qualification or passage of a single state ballot measure.</li> <li>• <b>Contributions Received:</b> List all new contributions of \$100 or more received by the committee that have not been previously reported up through the date of the \$5,000 or more payment.</li> <li>• Until the California Access Replacement System (CARS) is live, only e-filers file this report.</li> </ul>
<b>Within 10 Days</b> <i>Paid Spokesperson Report</i>	<b>Ongoing</b>	<a href="#">511</a>	<ul style="list-style-type: none"> <li>• File if either of the following expenditures related to an advertisement to support or oppose a ballot measure is made: 1) a payment totaling \$5,000 or more to an individual to appear in an advertisement, or 2) a payment of any amount to an individual portraying a member of a licensed occupation (e.g., nurse, doctor, firefighter). E-filers must also file a paper copy.</li> </ul>

### Additional Notes:

- **\*Period Covered:** The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1 if no previous statement has been filed.
- **Deadline Extensions:** Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to a 24-Hour/10-Day Contribution Report (Form 497) that is due the weekend before an election, and this extension never applies to any 24-Hour/10-Day Independent Expenditure Report (Form 496). Such reports must be filed within 24 hours regardless of the day of the week.
- **California Access Replacement System (CARS):** The new California Access Replacement System (CARS) is currently in development with an undetermined go live date. Once the California Access Replacement System (CARS) system is live, all state committees will file online or electronically with the Secretary of State.
- **E-filer:** Until the California Access Replacement System (CARS) is live, only state committees that have received contributions or made expenditures totaling \$25,000 or more e-file. Once the CARS system is live, all state committees must file online or electronically with the Secretary of State.
- **Forms 450 and 460:** All state committees, including e-filers, must also file paper statements. Paper statements may be filed by first class mail unless otherwise noted. Once the California Access Replacement System (CARS) system is live, all state committees will file online or electronically with the Secretary of State, no paper copies will be required.
- **Forms 496 and 497:** Payments for member communications are reportable within 24 hours if the member communication would otherwise be considered a contribution or independent expenditure, and the payments are made during the election cycle.
- **State Contribution Limits:** Refer to the [contribution limits chart](#) on the FPPC website.
- **Penalties:** Late statements and reports are subject to a fine of \$10 per day on both the paper and the e-filed version (e.g., \$20 per day for a late e-filed Form 460). Once the California Access Replacement System (CARS) system is live, all state committees will file online or electronically with the Secretary of State and late e-filed statements and reports will be subject to a fine of \$10 per day. Failure to file a statement or report could result in an enforcement penalty of \$5,000 per violation.
- **Public Documents:** All statements and reports are public documents.
