Filing Schedule for Committees Primarily Formed to Support/Oppose Local Measures Which Will be Voted Upon at the November 7, 2023 Election

Apr 30, 2023 <i>Quarterly</i>	1/1/23 – 3/31/23	460	<ul style="list-style-type: none"> Committees formed for a measure being voted upon on November 7, 2023 must file quarterly reports until the pre-election period begins for that election, regardless of activity.
Jul 31, 2023 <i>Semi-Annual</i>	* – 6/30/23	460	<ul style="list-style-type: none"> All committees must file this statement. The period covered is 4/1/23 – 6/30/23 if a quarterly report was filed.
Within 24 Hours <i>Contribution Reports</i>	8/9/23 – 11/7/23	497	<ul style="list-style-type: none"> File if a contribution of \$1,000 or more in the aggregate is received from a single source. File if a contribution of \$1,000 or more in the aggregate is made to or in connection with another candidate or another measure being voted upon on November 7, 2023 ballot, or made to a political party committee. The recipient of a non-monetary contribution of \$1,000 or more in the aggregate must file a Form 497 within 48 hours from the time the contribution is received. File by personal delivery, e-mail, guaranteed overnight service, or fax. The committee may also file online, if available.
Sep 28, 2023 <i>1st Pre-Election</i>	7/1/23 – 9/23/23	460	<ul style="list-style-type: none"> All committees must file this statement.
Oct 26, 2023 <i>2nd Pre-Election</i>	9/24/23 – 10/21/23	460	<ul style="list-style-type: none"> All committees must file this statement. File by personal delivery or guaranteed overnight service. The committee may also file online, if available.
Jan 31, 2024 <i>Semi-Annual</i>	10/22/23 – 12/31/23	460	<ul style="list-style-type: none"> All committees must file this statement unless the committee filed termination Forms 410 and 460 before December 31, 2023.

Additional Notes:

- * Period Covered:** The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1, if no previous statement has been filed.
- Local Ordinance:** Always check on whether additional local rules apply.
- Deadline Extensions:** Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to a 24-Hour/10-Day Contribution Report (Form 497) that is due the weekend before the election, and this extension never applies to any 24-Hour/10-Day Independent Expenditure Report ([Form 496](#)). Such reports must be filed within 24 hours, regardless of the day of the week.

- **Method of Delivery:** Unless otherwise noted, all paper filings may be filed by first class mail. A paper copy of a statement may not be required if a local agency requires online filing under a local ordinance.
- **Other Committee Expenditures:** Contact the FPPC if the committee makes independent expenditures/contributions to candidates and/or other measures. Additional reports may be required.
- **Multipurpose Organizations (including non-profits):** A multipurpose organization that uses its general dues account to make contributions or expenditures may qualify as a major donor or independent expenditure committee and may be required to report payments on Campaign [Form 461](#). Such an organization will qualify as a recipient committee if expenditures exceed \$50,000 in a 12-month period or \$100,000 in four consecutive calendar years. An organization that qualifies as a recipient committee may need to file reports disclosing contributors. - **Public Documents:** All statements are public documents.

- **Committee Status:** See FPPC [Regulation 18247.5](#) to determine if a committee is primarily formed.
- **Form 511** – Paid Spokesperson Report: File within 10 days of making either of the following expenditures related to an advertisement to support or oppose a ballot measure: 1) A payment totaling \$5,000 or more to an individual to appear in an advertisement, or 2) A payment of any amount to an individual portraying a member of a licensed occupation (e.g., nurse, doctor, firefighter).
