Dear Mr. Mutascio:

Thank you for your letter of April 15, 1986, requesting clarification of Government Code Section 81007 and FPPC regulation 2 Cal. Adm. Code Section 18116.

When a filing deadline falls on a Saturday, Sunday or official state holiday, the filing deadline is extended to the next regular business day. For example, if a filing deadline falls on a Saturday, the "next regular business day" is Monday. If a state holiday falls on a Monday, the filing deadline is extended to Tuesday.

Using my first example, a statement that is post-marked by mid-night Monday will satisfy the requirements contained in Government Code Section 81007.

I apologize for any confusion that may have arose as a result of our first response to your questions. Please do not hesitate to contact me if you have additional questions or need further clarification.

Thank you for responding to our request for clarification on the extension of filing time when a pre-election campaign statement deadline falls on a weekend.

I regret that our initial correspondence was not clear in its intent. We were familiar with the Regulations of the Fair Political Practices Commission Title 2, Division 6 of the California Administrative Code. Our request was for an interpretation of what is meant by the statement "...the filing deadline for such a statement or report shall be extended to the next regular business day."

Does that mean the report may be delivered only during the regular business hours? If a statement is mailed, must it be postmarked by midnight of the weekend filing deadline, by the end of regular working hours of the next regular business day, or by midnight of the next regular business day?

Thank you for your prompt attention to this matter.
