Dear Ms. Kibbe-Chairs:

This is in response to your letter requesting advice on behalf of the Oakland Unified School District concerning the application of the mass mailing provisions of the Political Reform Act (the "Act") to the mailings produced and distributed by your school district.<sup>1/</sup> Since your request does not refer to a specific governmental decision and is of a general nature, we are treating your request as one for informal assistance.<sup>2/</sup>

In your letter you requested all the "compliance guidelines, regulations and interpretations developed regarding Government Code Section 89001" in relation to your question concerning the Oakland Unified School District's mail procedures. The Commission has adopted Regulation 18901 to implement and interpret the mass mailing restrictions of Section 89001. A copy is enclosed for your reference.

QUESTION

May the Oakland Unified School District produce and distribute at public expense informational materials which include the names, pictures, signatures of or references to elected school board members?

CONCLUSION

Any use of a school board member's name, photograph or any reference to a member is prohibited if the mailing is initiated, directed or controlled by the member, or is signed by or credited to the member. In addition, any use of a member's name, photograph, office, or any reference to the board member is prohibited if the member is involved in the production or distribution of the mailing. If the school board members do not participate in the preparation or distribution of the mailing, then use of the board members' names is permitted provided they are not featured in the mailing.

DISCUSSION

Section 89001 provides that no newsletter or other mass mailing shall be sent at public expense. Section 82041.5 defines a "mass mailing" as more than 200 substantially similar pieces of mail sent in a calendar month, but excludes mailings sent in response to a specific, unsolicited request. Regulation 18901(c) provides that a newsletter or other mass mailing may not be sent within the meaning of Section 89001 if:

(1) The name of the elected officer or his or her photograph appears on the document; and

(A) The elected officer exercises direction or control over the content, production, or distribution of the document, or

(B) The document is sent at the request or suggestion of the elected officer or his or her agent; or

(C) The document is signed by, or is designated as being from, the elected officer or his or her office; or

(2) (A) The elected officer is affiliated with the agency which produces or distributes the document; and

(i) The elected officer is featured in the document; or

(ii) The name, office or other reference to the elected officer or his or her photograph appears on the document and the document is prepared or sent in cooperation, consultation, coordination or concert with the elected officer.

Thus, where the elected officer initiates the mailing, exercises direction or control over the content, production, or distribution of the document, or signs or takes credit for the document and the name of the elected officer or photograph appears in the document, it is prohibited under Section 89001. Moreover, where an elected official is affiliated with an agency that produces or distributes the mass mailing, the restrictions of Section 89001 may still apply in some circumstances.

An elected official is affiliated with an agency that produces and distributes a mass mailing if the elected official is a member, officer or employee of the agency or a subunit (such as a committee) of that agency; has supervisory control over the agency; or, appoints any of the members of the agency. (Riddle Advice Letter, No. A-89-096, copy enclosed.) Clearly, members of the governing board of the school district are "affiliated" with the district, which produces or distributes the mass mailing.

However, affiliation alone does not make the use of an elected official's name in a mass mailing prohibited. The second question is whether the mailing is prepared or sent in cooperation, consultation, coordination or concert with the elected officer. Where the mailing has been prepared or sent in cooperation, consultation, coordination or concert with the elected officer, any use of the elected officer's name, photograph or office, or any reference to the officer is prohibited. (Regulation 18901(b)(2)(A)(ii).)

If the mailing has not been prepared or sent in cooperation, consultation, coordination or concert with the elected officer, use of the elected officer's name is permitted provided the official is not featured in the mailing. (Regulation 18901(b)(2)(A)(i).) An elected officer is "featured" in a mass mailing if he or she is singled out for attention of the reader by use of his or her signature, inclusion in any photograph, or the manner of display of his or her name or office in the layout of the document such as by headlines, type size, or typeface. (Regulation 18901(b)(2)(B).)

Therefore, if the mailing is prepared or sent in cooperation, consultation, coordination or concert with the school board members, any use of the members' names, photographs, office, or any references to the officeholders are prohibited. If the school board members did not participate in the preparation or distribution of the mailing, then use of the members' names is permitted provided the members are not featured in the mailing.


In addition, Regulation 18901(e) sets out a specific exception to the mass mailing prohibition. Regulation 18901(e) permits the use of an elected official's name in the standard letterhead or logotype of the stationery, forms and envelopes of an agency. As used in this subdivision, the term "letterhead or logotype" includes a listing of agency or committee officials or members, in which all who are listed appear in the same typeface and type size and location in the layout of the newsletter or other mass mailing. (Regulation 18901(e)(2).)

Consequently, over 200 copies of the district mailings may be sent at public expense provided there are no names, photographs or references to elected officials, with the exception of a listing of agency members where all the names are set out in the same typeface, type size and location in the layout of the mass mailing.

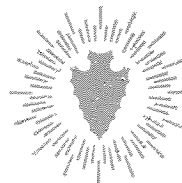

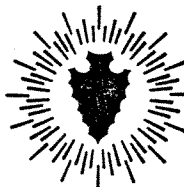

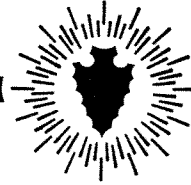
