**Warning Letter: Case No. 2019-00332; Ashley Colivas**

Dear Ms. Colivas:

The Enforcement Division of the Fair Political Practices Commission enforces the provisions of the Political Reform Act (the “Act”).<sup>1</sup> This letter is in response to a referral from the County of El Dorado. The Enforcement Division has completed its investigation and found that as a result of your position as a Deputy District Attorney IV with the County of El Dorado, the Act required you to periodically file a Statement of Economic Interests (“SEI”) and that you failed to timely file your Leaving Office SEI.

Section 87300 of the Act requires every state and local agency to develop a Conflict of Interest Code. This Code requires individuals who participate in making decisions which may foreseeably have a material financial effect on any financial interest belonging to that person to disclose all reportable interests on SEIs.<sup>2</sup> Individuals required to file SEIs must file within 30 days of assuming office, annually thereafter at the time specified by the Code, and within 30 days of leaving office.<sup>3</sup>

You violated the Act by failing to file your Leaving Office SEI by the specified deadline. But since you are no longer in office and have not had a prior violation of this section, the Enforcement Division has decided to close your case with this warning letter.

This letter serves as a written warning. The information in this matter will be retained and may be considered should an enforcement action become necessary based on newly discovered information or future conduct. Failure to comply with the provisions of the Act in the future will result in monetary penalties of up to \$5,000 for each violation.

Although the Enforcement Division is closing this case without seeking a penalty, you are still required to file all outstanding statements. Please contact your filing officer, Kim Smith at [kim.smith@edcgov.us](mailto:kim.smith@edcgov.us), for further information about your required filings. Any future non-filings may result in monetary penalties and this warning letter may be considered in any future enforcement actions.
