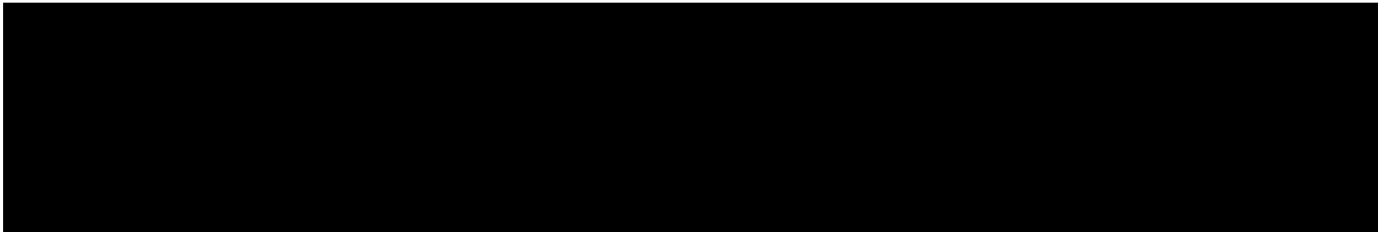

Throughout the year beginning in January of 2014, the law firm of Jones Day, and Elwood Lui as the senior counsel, represented me and all the sitting and retired judges of California in an action entitled Gilbert v. Chiang. The case involved an interpretation of Article VI, section 17 of the California Constitution. The issue was whether a retired judge could accept public employment during the time period that coincided with the judge's term of office.

In June of 2014, the Court of Appeal in Arthur Gilbert v. John Chiang 227 Cal.App.4th 537 held that once a judge retired from office that judge could accept public employment during the term for which the judge was selected.

I was the nominal plaintiff in the action which was of benefit to more than two thousand judges in the State of California.

Costs were awarded to the law firm Jones Day, and the value of the legal services spread out among the judges throughout the state was less than \$200.
