**Warning Letter re: FPPC No. 2024-01171; Susan Ralphs**

Dear Susan Ralphs,

The Enforcement Division of the Fair Political Practices Commission enforces the provisions of the Political Reform Act<sup>1</sup> (the “Act”). This letter is in response to a referral from the County of Los Angeles Executive Office of the Board of Supervisors. The Enforcement Division found that as a result of your position as a Board Member with the Golden Valley Municipal Water District, the Act required you to periodically file a Statement of Economic Interests (“SEI”) and that you failed to timely file your 2022 Annual and Leaving Office SEIs.

Section 87300 of the Act requires every state and local agency to develop a Conflict of Interest Code. This Code requires individuals who participate in making decisions which may foreseeably have a material financial effect on any financial interest belonging to that person to disclose all reportable interests on SEIs.<sup>2</sup> Individuals required to file SEIs must file within 30 days of assuming office, annually thereafter at the time specified by the Code, and within 30 days of leaving office.<sup>3</sup>

You violated the Act by failing to file your 2022 Annual and Leaving Office SEIs by the specified deadlines due the same calendar year. However, since you are no longer in this position and you have no prior Enforcement history, the Enforcement Division has decided to close your case with this warning letter rather than a fine.

This letter serves as a written warning. The information in this matter will be retained and may be considered should an enforcement action become necessary based on newly discovered information or future conduct. Failure to comply with the provisions of the Act in the future will result in monetary penalties of up to \$5,000 for each violation.

Although the Enforcement Division is closing this case without seeking a penalty, you are still required to file all outstanding SEIs and pay any late filing fees assessed by your filing officer. Any future non-filings may result in monetary penalties and this warning letter may be considered in any future enforcement actions.

A warning letter is an Enforcement Division case resolution without administrative prosecution or fine. The Commission has adopted Regulation 18360.1 to authorize the Enforcement Division to issue warning letters to conclude cases in specified circumstances. However, the warning letter resolution does not provide you with the opportunity for a probable cause hearing or hearing before an Administrative Law Judge or the Commission. If you wish to avail yourself of these proceedings by requesting that your case proceed with prosecution rather than a warning, please notify us within ten (10) days from the date of this letter. Upon this notification, the Enforcement Division will rescind this warning letter and proceed with administrative prosecution of this case. If we do not receive such notification, this warning letter will be posted on the Commission's website ten (10) days from the date of this letter.
