The term "pro rata share of any income of any business entity" as used in the last sentence of Section 82030(a) refers to the pro rata share of any net income of any business entity. The term "fees" as used in Section 87207(b)(2), however, refers to gross fees.

This interpretation was agreed upon by the staff during discussions relating to Frank Zolin's letter.
