Would you be kind enough to confirm your telephone advice of February 2, 1989 to Ms. Barbara Milman.

It is my understanding that Ms. Milman explained that Democratic Members pay for their caucus lunches annually, and in advance. the question asked concerned any FPPC rules or objections to the establishment of a lunch account the sole purpose of which would be to deposit members checks and pay the lunch caterers. This account would be administered by a staff member and not an elected Member.

It is my further understanding that you advised that such an account was permissible.
