Dear Mr. Balmages:

You have requested confirmation of telephone advice provided to you regarding the campaign provisions of the Political Reform Act,^{1/} specifically with regard to the contribution limitation provisions contained in Sections 85300-85307.

Your letter correctly states my advice that committees formed to qualify, support or oppose recall measures, and committees formed to do voter registration are not subject to the contribution limitations as long as the committees do not make contributions to candidates. This is because Sections 85300-85307 apply only to candidates and their controlled committees and to committees that make contributions to candidates.

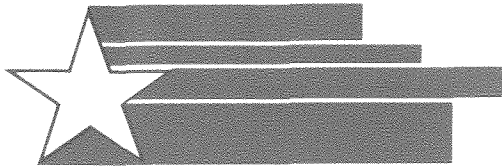

Dear Ms. Wardlow:

I am writing to confirm our telephone conversation of February 28, 1989. In that conversation, I asked you about contributions by individuals to two possible committees. One is the Orange County Voters Rights Committee which has been formed to promote voter rights including preventing harassment at the polls and doing voter registration. The other committee is The Committee to Recall Curt Pringle which has as its primary purpose investigating the possibility of and possibly doing a recall of a sitting Assemblyman. In answer to my question regarding contribution limits, you indicated that Proposition 73 contains no limit on the amounts individuals can donate to either of these committees, as long as none of the funds of these committees is used to support particular candidates.

You indicated in our telephone conversation that you could confirm the accuracy of this information. I would greatly appreciate your doing that by initialling the enclosed copy of this letter on the space indicated and returning it to me in the enclosed postage paid envelope.

Thanks for your courtesy and cooperation.
