**AB 1743 Fact Sheet**  
**Placement Agents: Lobbying Disclosure Requirements**

---

**What Forms Are Required?**

- If you are registered as a Lobbying Firm (Form 601) complete Form 625 - Report of Lobbying Firm.
- If you are registered as a Lobbyist Employer (either Form 603 or 602) complete Form 635 - Report of Lobbyist Employer.
- If you are an individual lobbyist/placement agent (Form 604) complete Form 615 - Lobbyist Report.

**How Do I File - Paper or Electronic?**

- All filers may file online with Secretary of State.
- If you reach the \$2,500 threshold, you must file electronically. No paper copy is required.
- If your activity is less than the \$2,500 threshold, you may file paper reports.
- Once you have filed electronically, however, you must file all subsequent reports electronically.

**When and Where Do I File?**

- All lobbying filers must file quarterly reports even if no reportable activity occurred. The reporting periods and deadlines are:

Jan 1 - Mar 31 - Due Apr 30      ~      April 1 - Jun 30 - Due Jul 31  
Jul 1 - Sep 30 - Due Oct 31      ~      Oct 1 - Dec 31 - Due Jan 31

- Deadlines that fall on a weekend or holiday are extended to the next business day.
- Paper reports are filed at: Secretary of State, 1500 11th St., Ste. 495, Sacramento, CA 95814, and must be postmarked no later than the due date.
- Free Online filing, as well as a list of software vendors, are available on the [Secretary of State's website](#).
- If you file electronically, no paper copy is required to be filed.

**What types of payments are reported?**

- Lobbying Firms report the percentage of their income received in connection with activity involving CA state retirement systems.
- Lobbyist Employers report the amount paid to in-house employees, lobbyists or lobbying firms for activity related to CA state retirement systems.
- All activity expenses (e.g. food, beverages) made to state officials.
- All campaign contributions made to state officeholders or candidates for state office
- All other payments related to influencing a decision by a CA state retirement system to invest CA state public retirement system assets.

**What types of expenditures are reported in "Other Payments" on Form 635?**

- Payments in support of your lobbyist (but not made directly to the lobbyist), such as the payment of a credit card charge for activity expenses.
- Travel and lodging in connection with meetings with officials of CA state retirement systems.
- Compensation paid to employees (other than a lobbyist) who spend 10 percent or more of their compensated time in a calendar month in connection with CA lobbying activities.

**Where on the Form 615 - Lobbyist Report do I report my salary as lobbyist/placement agent?**

- The Lobbyist Report is used to disclose payments **made** by a lobbyist/placement agent, not income received.
- The salary of an in-house employee lobbyist is reported on Form 635, Part II-A, Payments to In-House Employee Lobbyists. As noted above, salary should reflect only the percentage attributed to influencing matters before a CA state retirement system.

**What if I have nothing to report? Am I still required to file?**

- Yes. Quarterly reports are required to be filed regardless of the level of activity.
- Indicate "None" for what was actively lobbied.
- Do not leave sections blank - if there is no activity, place zeros. (See examples)
- Once you terminate, a final report covering the period you terminate in must be filed.
